Boarding Policies

All

We encourage owners to bring their own dogs bedding and toys that are familiar to them. Happy Dog Ranch will provide bedding if necessary.

We HIGHLY recommend bringing your own food to ensure consistency of diet. Happy Dog Ranch will provide an appropriate diet at no cost if food is not brought with the pet or if the food brought with the pet runs out.

Your dog will have access to water at all times.

Happy Dog Ranch is not responsible for loss or damage of any personal items.

Pets may be kenneled together if specifically requested, as long as the owner understands the risks involved: The added stress of being boarded and confined may increase and cause otherwise friendly companions to fight for space or food.

Dogs

Dogs must be brought in on a leash and collar.

Dogs will not be accepted for boarding if they are too aggressive for our staff to handle safely.

All dogs will be current on their vaccinations. Proof of vaccinations is required by check-in or boarding will be refused. Dog must be current on Rabies, DHPP, and Bordetella.

Cats

Cats must be brought in a carrier.

All cats will be current on their vaccinations. Proof of vaccinations is required by check-in or boarding will be refused. Cats must be current on Rabies and CCVRP.

Liability Waiver

I, _____, hereby certify that my dog(s), _____ is in good health and has/have not been ill with any communicable condition in the last 14 days. I have read and understand the following:

1. I understand and agree that, in the event of an emergency, Happy Dog Ranch, LLC will first attempt to contact the owner, seconded by an attempt to contact the emergency contact of record. Happy Dog Ranch, LLC may also contact the veterinarian of record directly, or an emergency veterinarian, if it is determined that immediate treatment is necessary. Happy Dog Ranch, LLC maintain sole discretion, without liability, in emergency matters. I agree to pay for all medical treatments received, including transportation to an emergency veterinary facility, promptly upon picking up my pet. I hereby agree to reimburse Happy Dog Ranch, LLC for veterinary costs, whether specifically authorized or not, in an amount which will be unlimited.
2. For Senior and Chronically sick pets: I understand that there are inherent risks in boarding a senior or chronically sick pet. Underlying health problems can be exacerbated by stress, and illness or infections, which would be minor in a healthy pet, but can become serious and even life threatening in an elderly or frail pet.
3. I understand and agree that Happy Dog Ranch, LLC and its staff will not be held liable for any problems that develop (e.g. injuries, fleas, ticks, and illnesses) during my pet's stay at Happy Dog Ranch, LLC.
4. I release Happy Dog Ranch, LLC of and from any and all responsibility for releasing your pet to any person to be authorized by yourself.
5. Happy Dog Ranch, LLC shall exercise reasonable care for the pet while boarding. It is agreed by the owner and kennel that the kennel's liability shall in no event exceed the lesser of the current chattel value of the pet of the same species or the sum of \$200.00 per animal boarded.
6. Storm Disclaimer: In case of storm, Happy Dog Ranch, LLC cannot guarantee the safety of owners' pets. Happy Dog Ranch, LLC agrees to make every effort possible, without endangering kennel staff, to care for animals entrusted to us. It should be understood by owner that should conditions warrant we too may be forced to evacuate premises. Owner agrees not to hold Happy Dog Ranch, LLC responsible for injury or loss of pet due to above mentioned fact.
7. This contract contains entire agreement between parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives of the pet owner and the kennel.
8. I further understand that if my dog is left at Happy Dog Ranch, LLC for a period of 48 hours beyond the agreed pick up date, without contact from the owner, this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities.
